6.20 a.m. - Leaving the New County Offices, South Block, York Road, by car.

Arrive - Lollard Street School Rest Centre for air-raid victims.

Return - County Hall: Breakfast at the Home Guard Canteen.

At work at his desk.

11 a.m. - Leaving the New County Offices travelling by mobile canteen.

Arrive - Penrose Street, Walworth Road. Incident at which
Rescue personnel are at work. Tea will be served to
some of the personnel from the canteen.

Passe on to Damaged Rescue depot at Penrose Street School at which the men working on the incident are stationed.

Proceeds to Sayers Street School Communal Meals Centre - serve the meals for eating off premises.

12.20 p.m. - Lunch at the Centre with air-raid victims.

Proceed to Site in Camberwell being cleared of debris under new .

Debris Removal Scheme. Issue tea to personnel.

Call at - Auxiliary Ambulance Station No. 170 in South Lambeth Road.

Proceeds to Fire Brigade Headquarters and visits the underground control room, the nerve centre of London's fire fighting organisation.

Leaves - Headquarters to inspect the emergency fire floats moored at the jetty opposite.

Proceed - By fire float down river to Blackfriars River Station.

Pick up - Car at Blackfriars Bridge and return to County Hall.

3.30 p.m. - Tea on the Terrace.
