3. S.V. In-fighting with each boxer holding in turn. 12 Gor.
4. S.V. Proietti flaying Thompson, who lies on ropes. Bell. Boxers go to their respective corners. 17 Rud.
5. C.U. Type laughing. 2 Gor.
6. M.V. Thompson receiving attention in corner. 4 Gor.
7. S.V. Proietti receiving attention in corner. Bell for start of next round. 4 Gor.
8. S.V. In-fighting. They break up and Proietti starts two-handed attack to Thompson's head and body. 15 Rud.
9. S.V. They both exchange blows. (This scene for low blow). 10 Gor.
10. M.V. Proietti breaks away from Thompson, holds groin and grimaces but carries on boxing. (Loud boos from crowd). They dance round ring. Referee calls 'break'. They break, dance away and Proietti lands left hook to Thompson's chin, followed by another immediately after. Proietti carries on two-handed attack. 41 Rud.
11. S.V. Both boxers landing with light lefts. 6 Gor.
12. M.V. Thompson, by ducking cleverly, avoids Proietti's left jabs. They tie up in corner. Referee calls 'break'. 16 Rud.
13. S.V. Timekeeper ringing bell. 2 Gor.
14. M.V. Proietti escorts Thompson to his corner. 9 Rud.

- 5. I.V. C.U. Type laughing. 18 Cor.
- 6. I.V. Thompson receiving attention in corner. 18 Cor.
- 7. I.V. Proletti receiving attention in corner. Bell for start of next round. 18 Cor.

- 11. I.V. Both boxers landing with right fists. 18 Cor.
- 12. I.V. Thompson, by ducking slightly, avoids Proletti's left jab. They tie up in corner. Referee calls 'break'. 18 Cor.
- 13. I.V. Ringkeeper ringing bell. 18 Cor.
- 14. I.V. Proletti escorts Thompson to his corner. 18 Cor.
