- 5. M.V. Walzack sails in but Robinson calmly steps back. Walzack throws wild left. Robinson back-peddalling comfortably. Robinson throws right to Walzack's stomach and a right under-arm. Walzack goes down obviously hurt. 22

- 7. S.V. Walzack fights back but more heavy body blows by Robinson force Walzack to hold. 17
