DRUMMONDS SLAYING
Lurs, November 14th.1953
Positive Whdeveloped: 75 meters = 250 ft

After long hours of hearing in the Justice Hall of Digne, by Inspector Sebeille and his suberdinates the two DOMINICI brothers finally told the policemen that their father was the slayer of the Drummond family 15 months ago.

Taken back to their farm where the old man is dominating his whole family the brothers immediately and separately show the Inspectors where the Rock machinegun was hidden when it was still their father's.

Arriving at the farm, police officials are met by the angry crowd of Dominici femadas, still loudly claiming that the Dominici family has nothing to do with the crime. The police car is surrounded by the angry crowd, but nevertheless the two brothers Clovis and Gustave Dominici show the hiding place of the grn.

They are then taken back to Police headquarters in the Justice Hall of DIGNE, where a crowd has gathered, mingling with reporters awaiting further informations.

This morning in Lurs took place the reconstitution of the event, and latest report are that the old man Gaston DOMINICI tried to commit suicide after stating he himself slew the Drummond.

I5 months after the discovery on a fine automn day, of the bodies of Sir Jack DRUMMOND, his wife Lady Ann and their eleven-year old daughter Elizabeth, near their car, on the road where they had been camping, French Police who had been working on the case eversince finnally got old farmer Gaston DOMINICI to admit he slew them.

This material which was shot on the spot of the crime a few days after the discovery, shows:

-From townhall of the small village of PETT PEYRUIS, police officials and detective drive to the killing's spot.

-A british newspaper offers IOOO Pounds for any information helping

to arrest the slayer.

- on the river Durance's embankment, the spot where little Elizabeth ran away from her killer and was stepped by the river.

-shots of police inspectors during their inquest, on the spot Elizabeth's

-body was found/

- The water pool on the side of the river where the Rock american built shotgon which had been used by the murderer was found

- Policemen in front of the roadside stone where Sir Jack's body was found, they show reporters where the car and Lady Ann's body were.

- views of the Dominici farm, a short way from the spot where the

Drummonds camped

- Crowd gathering on the killing's spot

- views of the Dominici farm, and neighbourhed farmers talking about the event
- In the small FORCALQUIER cimetery graves of Sir Jack, Lady Ann and little Elizabeth Drummond
- Shot of Inspector SEBEILLE who handled the case and finally got the statement of the old farmer.
