CIVIL DEFENCE PARADE AND REVIEW BY THE HOME SECRETARY ON HORSE GUARDS PARADE SATURDAY, 5TH DECEMBER, 1953.

(Ref. announcement from Home Office dated 27.11.53.)



Among the 1,000 strong Civil Defence detachments expected to be on parade "to meet the Home Secretary" on Horse Guards Parade on 5th December, will be people from all over the County of London and other areas within the London Civil Defence Region, who have become volunteer fire-fighters, ambulance drivers and attendants, and members of mobile rescue teams and first aid units.

Quite apart from the importance to everyone of Civil Defence, this biggest yet Civil Defence Parade in London will have a personal interest not only for those on parade and their families but also for a great number of their friends and neighbours some of whom are themselves civil-defenders.

The Auxiliary Fire Service will be represented by a detachment on foot of 60 firewomen, leading firewomen and senior leading firewomen; and a mobile column manned by auxiliary firemen and firewomen and comprising a column control unit, 5 company control units, 50 pumps, a hose lorry, foam tender, communications unit, mobile kitchen, canteen van, maintenance van and despatch riders - about 70 vehicles in all. The whole Auxiliary Fire Service contingent will be under the command of Auxiliary Divisional Officer Burnham (London Fire Brigade/Headquarters) whose home is at 200, Kings Hall Road, Beckenham, Kent. Divisional Officer Burnham joined the Beckenham Auxiliary Fire Service in May, 1938, and served in a part-time capacity until September, 1939. On mobilisation he became a whole-time company officer and was promoted to column officer and then to divisional officer, which rank he held until May, 1946. He rejoined the Auxiliary Fire Service in May, 1950. In addition to being a M.B.E., Mr. Burnham has been awarded the Coronation Medal.

The detachment of firewomen and their officers will be under the command of Auxiliary Assistant Group Officer (Mrs.)

Margaret S. Jacobs (London Fire Brigade/Headquarters) who lives at 122, Clarence Gate Gardens, N.W.1.

The Senior Woman Auxiliary Officer in the mobile column will be Mrs. Joyce S. Hicks, O.B.E., whose home is at High Wold, Woldingham, Surrey.

The Auxiliary Fire Service contingent will include auxiliary firemen and firewomen from the counties of London, Surrey, Middlesex, Hertfordshire and Kent and from the county boroughs of Croydon and West Ham.

A list of personnel in charge of appliances in the mobile column with some interesting notes about a few of them is attached (Appendix I).

The contingent will begin to assemble at London Fire Brigade Headquarters at 10 a.m. on 5th December and will move off at 10.45 a.m. from Albert Embankment. They will return to London Fire Brigade Headquarters for lunch after the Parade.

The London Ambulance Service Civil Defence contingent will comprise a detachment of about 60 volunteers on foot; and a mobile detachment of 6 ambulances. Details of the men and women volunteers taking part are attached (Appendix II).

The detachments will assemble at 10 a.m. at County Hall.

The Rescue Service will be represented by a detachment on foot of 60 members of the Civil Defence Rescue Service and a mobile detachment of 6 rescue vehicles. Personnel will be from Croydon as well as London. In charge of the detachment on foot will be Mr. Cyril Jordan of 27, Sheridan Road, Bexley Heath, Kent. The mobile detachment will be under the command of Mr. J. E. Carleton of 3B, Wordsworth Parade, Green Lanes, N.8. Both are experienced Rescue Service instructors. Mr. Jordan was in the Heavy Rescue Service in the last war although later he was a sapper officer in Burma and India. He was awarded the Coronation Medal.

Mr. Carleton was an R.A.F. pilot, engaged on close support work with Transport Command, South East Asia. The rescue detachment will include Mr. K. H. Ahmed of 22, Collingham Gardens, S.W.5, who comes from Pakistan and Mr. E. Forster-Jones of 29, Otford Crescent, S.E.4, who comes from Lagos, Nigeria. Mr. A. V. Bean, the leader of a Lewisham rescue party whose home is at 113, George Lane, S.E.13, is a Coronation medallist. The Rescue Service detachments will assemble at County Hall at 10 a.m.

Mobile First Aid Units - There will be a total of 8 vehicles and about 100 members of the National Hospital Service Reserve taking part, including teams from the areas of all four Regional Hospital Boards for London. Mobile units will include teams from Enfield Group Hospital Management Committee (North East Regional Board -a team from which won the challenge cup presented by the Minister of Health in September, 1953; from Barnet Group Hospital Management Committee (North West Regional Board) - a team from which won the Regional Challenge Cup holders for 1953; from Bromley Group Hospital Management Committee (South East Regional Board) - holders of the South East Regional Challenge Cup for 1953; and from Chelsea Group Hospital Management Committee (South West Regional Board). Detachments on foot will include N.H.S. Reservists from the following Group Hospital Management Committees:-

North East Regional Board - Hertford, Edmonton, Chelmsford, Colchester, Central, Hackney, Stepney, Bow, West Ham, Forest (Walthamstow and Woodford), Ilford and Barking, Romford, S.E. Essex, Brentwood, Epping.

North West Regional Board - Paddington, Archway, Hendon, Northern, Windsor and S.W. Middlesex.

South East Regional Board - Bromley.

South West Regional Board - Lambeth, Croydon, Worthing, Winchester and Westminster Hospital.

Experimental Mobile column - Details of this are available via the Press Officer, Home Office. The Column is to take part with other civil defence services in a large scale Civil Defence Exercise at Bully Fen, Hackney, at about 8 p.m. on Thursday, 3rd December. Further information to follow.
