PRINCESS MARGARET TO OPEN WEST INDIAN STUDENTS CENTRE IN LONDON

The West Indian Students Centre at No. 1 Collingham Cardens, S.W.5., which is being opened by Her Royal Highness The Princess Margaret on Wedresday, June 1, will provide West Indian students in the United Kingdom with a central club and a place to entertain their friends. The Centre, which is situated in a residential area in Earls Court, has been entirely redecorated and furnished. The capital cost of the premises amounts to approximately £20,000, and is being provided by the West Indian Governments who will also contribute to the furnishing and recurrent costs of the Centre. Many of the special fittings and amenities in the Centre have been presented by business houses and others interested in the West Indies and in the welfare of the students in the United Kingdom.

Students using the Centre - and there are over 2,000 West Indian students in the United Kingdom - will find many amenities including a library and writing room, a games room, a television room and a billiards room, besides a reception lounge, drawing room, dining room and canteen. Later, it is hoped to equip other rooms as dormitories for students visiting London for examinations, and to open hairdressing saloons in the Club. The West Indian Students' Union will also have an office in the building.
