Roll 1.

Showing the Archbishop Makarios having meet with Sir John Harding the Governot of Cyprus, at the Anglical Archdeacen's house.

Next shots to follow are from the 2 trials of the EOKA people brought up for tial,.

Long shot of the special court at Nicosia where the political cases are taking place. soldiers are also guarding the court to prevent any disderbances....shot of the entrance of the court with wires and a Guard of the South Staffords....another of the South Staffords at the back side of the court premoses wokling along with a Cypriot special constable....Alexanaros Panazis taken off the court on a chair owing to his wounded leg to the police car to be taken to police custody He is the one who on the 14th. December shot at Ledra Street the servie-man Collins Percy when later he run away and was shot by an officer in cevillian clothes. his case is continued. According to the new regu- lations of law he is liable till the death penalty....Another shot to follow is the car which is taken him off the court yeard to the police...

Roll 2.

It starts with the secano trial at the same court in the afternoon of another sereous political case... The representatives of the Bishopic of Kyrenia where is the Bishop KYPRIANOS and of the ktharchy member for the movement of Union here they are entering the gate of the special court to attent the trial of the cousin of Bishop Kyprianos where he was arrested at the SPILIA mountain search by the security forces (Commandos) runing away the blocated area with a pistol he was shot at the arm and captiard on the 11th. Dec. 1955. to follow the 2 priests are women relatives to the accused permitted also to attent the trial....Next is the accused taken to the court with escort of police and army guarding the place while people are waiting him to pass..The accused entering the gate and shown him entering the court gate. His case also is liable till the death penalty.....next at the main entrance of the court house showing a sign on the wall saying that the bussiness are going on. it means that although trouble are still going on the court carried out justice.. two more shots of the people entering the opurt are searched by the special constable Cyprus police... (the rest of about 27 feet was left in the camera for it was a rumour that the Archbishop and Governor might have another meeting tonight. but will be later this week).
